PERSONS EMPLOYED IN ONE HANDLING

*204. SHRI A. P. CHATTERJEE: Will the Minister of PARLIAMENTARY AF-FAIRS AND SHIPPING AND TRANS-PORT be pleased to state:

- (a) whether the Chairman of the Visakhapatnam Port Trust and the Ministry have received complaints about the dust hazard to persons employed in ore handling operations at the port;
- (b) whether a number of persons working at the Visakhapa nam Port Trust have been suffering from such diseases like T.B., chest pain and general deterioration of the system; and
- (c) whether Government propose to set up a Committee of Experts to investigate into the matter of occupational hazards in ore handling as well as other allied occupations?

THE MINISTER OF PARLIAMENTARY AFFAIRS, SHIPPING AND TRANSPORT (SHRI RA] BAHADUR): (a) The Visakhapatnam Port Trust has received certain representations about dust hazard.

- (b) Four persons working in the Visakmapatnam Port have been found suffering from T.B., but medical examination has shown that it was not due to dust. No cases of chest pain or general deterioration of health have been reported.
- (c) An Expert Committee on Occupational Diseases in respect of all dock workers of the Major Po ts was set up by the Ministry of Labour and Employment in March, 1970. One of the terms of reference of the Committee is to conduct a survey of all occupational health hazards, likely to produce occupational diseases among dock workers. The report of the Committee is awaited.
