Advances by Reserve Bank of India against Oilseeds

S17. SHRI K. L. N. PRASAD: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that the Reserve Bank of India has tightened control on advances against oilseeds, vegetable oils and vanaspati to check their rising prices;

(b) if so, how far these measures have checked the prices of these commodities; and

(c) what additional steps Government propose to take in this regard?

THE MINISTER OF FINANCE (SHRI Y. B. CHAVAN): (a) Yes, Sir.

(b) The wholesale price indices for the week ended March 31, 1971 indicate that the prices of edible oils and oilseeds have declined by 5.5 per cent and 9.1 per cent respectively since the control on bank ad vances against these commodities was tighte ned by the Reserve Bank of India on January 25, 1971. Prices of vanaspati, which are subject to control, were also reduced in January for the East lone anil in February for the North zone.

(c) Apart from initiating various pro grammes for raising the internal production of oilseeds, the Government have arranged for imports of soyabean oil/sunflower oil; mutton tallow for the soap industry is also being imported to relieve the pressure of de mand on edible oils. In addition, efforts are being made to lap the oil potential of minor seeds.
