

#### SUBMERGING OF KAKANAKOTE FOREST IN THE KAIUNI RESERVOIR

197 SHRI A. I). MAM: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) whether Government are aware that the Kakanakote Forest in Mysore is going to be submerged in the Kaiuni reservoir thus depriving tourists of a major lion in Mysore, viz., hunting of elephants; and

(b) whether there are any proposals under Government's consideration to have a saneman (or elephants in the country so that the elephant population may be properly preserved)

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) A portion of the Kakanakote (OHM) will be submerged under the Kabini Project, but the adjoining areas will still be available for giving shelter to elephants. Hunting of elephants is prohibited in Mysore and cannot therefore be considered as an attraction for tourists.

(b) No Sir. The existing wild life sanctuaries and National Parks are adequate for the preservation of elephants

complaint with the Government of India as well as with the Company Law Board about the appointment of Managing Director and Deputy Managing Director respectively of the said mill at fabulous salaries;

(b) if so, what action Government have taken in the matter;

(c) whether his Department granted their approval to the appointment of the said Managing Director and the Deputy Managing Director; and

(d) if so, the grounds on which such approval was granted?

THE MINISTER OF COMPANY AFFAIRS (SHRI K. V. RAGHUNATHA REDDY): (a) A shareholder of the Shankar Sugar Mills Limited had objected to the managerial appointments proposed by the company with the approval of the shareholders at its meeting held on 1st December, 1969;

(b) The Company Law Board considered (in company's application in the light of the objections raised by this shareholder);

(c) The Company Law Board approved the appointment of a Managing Director and a Deputy Managing Director each on a reduced remuneration of Rs. 2,500 per month plus one per cent commission restricted to 50 per cent of their annual salary plus perquisites; and

(d) The Company Law Board which is a statutory authority, considered all facts and circumstances of the case and decided in company's proposal on merits.

#### CALCUTTA TRAMWAYS COMPANY LIMITED
