HEALTH SCHEME FOR GOVERNMENT PENSIONERS

- *225. SHRI J. S. TILAK: Will the Minister of HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT be pleased to state:
- (a) whether Government Health Schemes are applicable to Government pensioners and their families throughout the country;
- (b) if so, what are the details thereof; and
- (c) whether there are some State Governments which have not made the Scheme applicable to Government pensioners and their families, and in such cases whether Government propose to ask those State Governments to make it so applicable?

THE MINISTER OF HEALTH AND FAMILY PLANNING (SHRI K. K. SHAH): (a) The Central Government Health Scheme has been extended by the Central Government to Government pensioners and their families who may be willing to avail of such facilities and are residing in Delhi/New Delhi, Bombay and Allahabad in the areas covered by the Central Government Health Scheme dispensaries.

- (b) A statement is laid on the Table of the Sabha.
- (c) Health is a State subject. It is, therefore, for the State Governments to evolve Health Scheme for their employees, pensioners and their families, if they so desire.

STATEMENT

Details of the Central Government Health Scheme applicable to the Central Government Pensioners residing in Delhi/New Delhi/Bombay and Allahabad.

The Government of India have extended the medical facilities under the Central Government Health Scheme to Central Government Pensioners who may be willing to avail of such facilities and are residing in Delhi/New Delhi, Bombay and Allahabad in the vareas covered by Central Government Health Scheme dispensaries irrespective of the amount of pension they are in receipt of.

(i) Scope

The beneficiaries will be Central Government pensioners including those who have retired with C. P. Fund Benefits, widows of the Central Government Pensioners in receipt of family pension or a child who draws pension after the death of the Central Government servant and his wife, residing in Delhi/New Delhi, Bombay and Allahabad, only in the areas covered by the Central Government Health Scheme.

The beneficiaries will be Central Government pensioners their widows in receipt of family pension and members of their families ("family" is defined as pensioner's wife or husband as the case may be, children and stepchildren and parents who are mainly dependent on and residing with the pensioners concerned).

(ii) Contribution

The beneficiaries who join the scheme will be liable to pay contribution on a sliding scale with reference to their gross pensions in the case of pensioners and with reference to half of their last substantive pay drawn in the case of those retiring with C. P. Fund benefits.

They will be entitled to the facilities available to serving Government employees earning the same emoluments. Continuous treatment at the same level as on the the date of retirement could

be considered on payment by the pensioner of contrilution charged on the last pay drawn.
