

(iv) Steps taken by Railway in this regard

Steps taken by Railway in this regard are:—

- (i) Periodical re-assessment of forecasts for major streams of traffic in consultation with industries/ Ministries concerned and Planning Commission.
- (ii) Intensive drive to attract high rated traffic.
- (iii) Better security arrangements in co-ordination with Railway Protection Force and Civil and Railway Police.
- (iv) Patrolling of track and yards and providing armed escorts for goods trains wherever necessary in affected areas.
- (v) Co-ordination by criminal intelligence wing of Railway Protection Force and the Civil and Railway Police to track down the agencies indulging in such thefts and purchase of stolen materials.
- (vi) State Governments have been approached to help the Railways by controlling interference of undesirable elements.
- (vii) Replacement of copper wires/ conductors and wagon brass, bearings by aluminium/graphite-cast iron and other metals not subject to theft due to lesser value, v

TAKE OVER OF ANDHRA SCIENTIFIC COMPANY
