(c) In all eight proposals had been received. These were examined in detail by groups--one two study Financial and the other Technicaland four of the proposals were not considered suitable for further consideration for one or more of the following reasons:---

(i) The vehicle offered was not a four door model for which there is customer preference in the country;

(ii) The vehicle offered was not of a proven design;

(iii) The foreign firm did not have sufficiently long experience, large volume of production and experience of export to tropical countries and of setting up plants in other countries.

(iv) The capital investment proposed was very high as compared to the offers of the other parties.

Accordingly, it was decided to confine further consideration to the offers of the remaining four parties mentioned in reply to part (b) above.
