REFERENCE TO LOCATION OF A SECOND STEEL PLANT IN ORISSA

BANKA **BEHARY** SHRI (Orissa): Mr. Deputy Chairman, I will be very brief. Despite the desire of this House and the other House expressed during a discussion on the issue of the second steel plant in Orissa, that Orissa should be given a steel plant during the Fourth Five Year Plan, up till now the Government of India has not accepted that position. Not only thet. The Orissa Legislative Assembly unanimously passed a resolution that a steel plant in the public sector should be set up by the Government of India in Orissa. You know that last time I

ail the Members of Parliament from Orissa held z dharna before the Prime Minister's residence. Yesterday, not only Members of Parliament, but all the Assembly members of Orissa including the Deputy Speaker held a Prime dharna before the Minister's residence. Before resorting to the dharna. there was a discussion with the Prime Minister in her compound. We are very sorry to say that the Prime Ministei did not give any assurance that Orissa wtil get a steel plant during the Fourth Five Year Plan. That is why the entire Orissa is agitated. I am drawing your attention to this fact that these are all peaceful methods that Orissa has adopted so far. Whether i; 13 i total strike or whether it is dharna by M.Ps.. or M.Ps. and Members, it was all peaceful. Assembly Today at 11 o'clock a group of young men belonging to Smaj-vadi Yuvak Sabha demonstrated before the mein gate of the Parliament House. They were arrested. Their demonstration was peaceful. They only said: "We demand o second steel plant in Orissa". I want to draw the attention of the House that this House and the Other House given general support to this demand. But now it seems, as indicated during the question hour, that the Indian Government is again talking of the capacity of Rourkela steel plant. Nobody bothered about the capacity when steel plants were allotted to other States. We may assure the Government of India that capacity of Rourkela will be attained because Orissa is interested in the Rourkela steel plant. We will not allow Rourkela to go down, as some people are thinking in that manner. 1 wish to draw your attention that if the Government of India during this Session, do not come out with a forthright statement that Orissa will be given a second the Fourth Plan and steel plant during be made preliminary arrangements will accordingly, both technical -and otherwise, then the situation will go cut of hand which we do not want. The entire Orissa people will have to resort to the streets and then I do not know whit will happen. So I am drawing attention of the House and the the Government that this is the situation that is obtaining in Orissa and if the desires of the people of Orissa are not satisfied, then • the consequences will be disastrous not only for Orissa but for the entire country. I am not giving a warning or threat but I am sayins that if you keep the people in a

discontented manner for a long period, the consequences will be unrest which may not be to our likins; or to the liking of the nation but a warning is to be given and I am sounding it through this House because 1 know this Hi use and the other House have supported this demand.

In the end I wish to say that we want a steel plant in t is public sector by the Government of India because All-Parties Sangram Committee, which is composed of all political parties in Orissa has clearly stated that the -econd steel plant will not be in the private sector nor wilt it be set UJJ by the State Government because the State Governmeii has no finance but it should be by the Government in the public sector. I am voi tog the demand of my party and that of all the political parties associated with tie Sangram Committee.

SHRI NIREN GHOSH (West Bengal): Why do you not demand powers over trade, commerce md finance so that you can set up the plant yourself? Mount an agitation for that

SHRI BANKA BEHARY DAS: I will be very happy if your party can do some planning in your own State and then get us the powers.

SHRI NIREN GHOSH: If we take those powers from the Centre. I promise we will also give it to you.

SHRI BANKA BEHARY DAS: I want to say emphatic-all to the Government of India that the resources of Orissa are very limited and they cannot set up a steel plant and if any other foreign power comes and sets it up. virtually it will be under their control. Secondly, I wish to say that the Orissa Asiembly in their unanimous resolution, has categorically stated that the steel plant will be in the public sector and the Government of India should set it up. We do not want to resile from that position. I want to draw your attention to this demand and I will be very happy if the Minister concerned will come out to-day and give an assurance and categorically declare that Orissa will have the second steel plant during the Fourth Plan.

SHRI LOKANATH MISRA (Orissa): I want to reiterate he demand made unanimously by the people of Orissa through the elected representatives—the Members of

the Vidhan Sabha and the Members of Parliament-who sat in a dharna before the Prime Minister's house yesterday demanding that the Prime Minister should give & categorical assurance that the second steel plant would be given to Orissa during the Fourth Plan. We have been agitating for the last six months in Orissa and the whole State is agitated about the grave injustice done by the Central Government to the people of Orissa. We have been agitating in a very peaceful manner and this method of peace should not be construed as a sign of weakness. If they treat this as a sign of weakness, probably they will be very wrong in their understanding of the sentiments of the people of Orissa. The unanimous demand was there in this House and the other House. Any democratic Government would have definitely followed the wishes of both the Houses of Parliament. This is a Government which apparently does not believe in democratic methods nor in the democratic instructions given by democratic institutions. If both the Houses of Parliament unanimously resolve that Orissa should be given a second steel plant, who is this Government to stand in the way?

SHRI P. C. MITRA (Bihar) In the public sector?

SHRI LOKANATH MISRA: We demand it in the public sector.

SHRI P. C. MITRA: But the Swatantra Party has passed a Resolution to the effect that there should not be steel plants in the public sector any more. And the kon. Member is acting against his Party decision.

SHRI LOKANATH MISRA: For the information of the hon. Member. Mrs. Indira Gandhi does not act according to the instructions of the Swatantra Party.

SHRI GODEY MURAHARI (Uttar Pradesh): He is not the Minister.

SHRI LOKANATH MISRA . He is not yet a Minister, of course, but I do not want to bring him in personally. I only want to add to his information and knowledge and wisdom that Mrs. Indira Gandhi is not under the dictation of the Swatantra Party but, Sir, (Interruptions) she wishes to act definitely under the instructions o'' both Houses of Parliament if she wants t >

call herself a democratic Prime Minister \Leftrightarrow £ India. But she is now acting in manner which does not seem that she believes in the democratic pattern of Government. If she does, than I hope, and I would earnestly urge on her through you that the Prime Minister make a statement reviewing the previous stand and proclaiming here that Orissa would get a second steel plant during the Fourth Five-Year Plan period.

If you look at the rules, only those things which are unparliamentary can be expunged. You may be the Deputy Chairman of the House but yow have no rig it to override the rights and privileges of the Members.

MR. DEPUTY' CHAIRMAN: What I have done has been the usual practice.

SHRI A. P. CHATTERJEE : Under what rule can you do that? I would like....

MR. DEPUTY CHAIRMAN: All right, sit down. Your point of order is over now.

SHRI A. P. CHATTERJEE: I want to know specifically under what rule you have said that.

n. REPORT OF THE COMMITTEE ON UNTOUCHABRITY. ECONOMIC AND EDUCATIONAL DEVELOPMENT OF THE SCHEDULED CASTES—contd.

SHRI K. S. CHAVDA (Gujarat) : Sir, yesterday I was speaking . . .

SHRI NIREN GHOSH (West Bengal) : Sir, I am beholden to you . . .

THE VICE-CHAIRMAN (SHRI BANKA BEHARY DAS) : Mr. Chavda, you continue.

SHRI K. S. CHAVDA: Mr. Vice-Chairman, yesterday I was speaking regarding the housing scheme for the Scheduled Castes implemented by the former Bombay Government when our Prime Minister former Deputy Morarjibhai Desai was Chief Minister of Bombay. Somebody, one Member from the ruling party, interrupted me. The former Bombay State was the first in forming the Forest Labour Cooperative Societies for the Scheduled Tribes who were exploited by the rich people. They were Sponsored under the Chief Ministership of Shri Morarjibhai Desai. He is the pioneer of these Forest Labour Cooperative Societies in the whole of India, and he is the Chairman of the All India Adim Jathi Sewak Sangh. Sir, at that time, the Scheduled Caste students were not allowed into the primary schools. Then he applied the 'presumption clause', that if the Scheduled Caste students were not found present in the primary schools, it would be presumed that they were not admitted due to untouchability. Hence the schools would be closed. It had a very good effect and all the students were admitted in the primary schools' in the Gujarat area of the State.

Sir. regarding prohibition which is meant for the benefit of the Scheduled Castes and the Scheduled Tribes and also the weaker sections of the society, if a person whose income is above Rs. 2.000' drinks, he ruins' himself only. But if a person whose annual income is below Rs. 2,000 drinks, he ruins not only himself personally but also his family. That is why I say that prohibition is in favour of the weaker sections of the Scheduled Cas'tes and the Scheduled Tribes. Sir, everybody knows that Mr. Morarji Desai is a staunch prohibitionist. So I would like to draw the attention of the House as also of the Home Ministry regarding the suggestions' he made while speaking on the report on the 4th September in the Lok Sabha. I am quoting from the synopsis of the Debate in the Lok Sabha. He said:—

"As regards the recruitment of these people in the services, there was no reas'on why they should not get a full opportunity which we said we were giving them. Deprived of remaining in society on equal basis they could not imbibe the manners, customs and traditions which other people Therefore, when an examination place, it was not possible for them to stand equal with all. But the most difficult part was the oral examination. In the oral examination it was not possible for these people to satisfy the, examiners who were from quite a different level. It was. therefore, necessary that the oral examination should be done away with so far as these people were concerned. If they passed the written test according to what was prescribed, then the oral test should not debar them from being employed." 1 would like to know from the Home Ministry what action has been taken regarding this very good suggestion so far as this employment question of the Scheduled Castes and the Scheduled Tribes people is concerned because, Sir, the Home Ministry is the policymaking body regarding the recruitment, appointment, confirmation, promotion and things regarding the services all these and posts in the Government.
