**SHRI M. K. MOHTA (Rajasthan):** May I ask whether ships belonging only to India joined in the search for this missing ship or ships of other countries also joined in the search? Were there ships of other countries in the vicinity and was any appeal sent to any of them and did any of them respond? As regards the aerial search, also, was the aerial search conducted by the aircraft of our country only or those of other friendly countries like Burma or East Pakistan also joined in the search?

**SARDAR IQBAL SINGH:** Two were Indian ships and one was a foreign ship. They have responded to the call and have come to the rescue. They were the nearest ships which we could ask for help. If the ship was far away, there would be no use asking them for help. They were the nearest ships in that area and we have asked them for help. They have responded to our call. Regarding the aircraft, it is still continuing the search. Regarding the query whether Pakistan and Burma aircraft also joined, I have no information.

**SHRI M. K. MOHTA:** Was the appeal sent to any other foreign ship but it did not respond even though it was in the vicinity?

**SHRI K. RAGHURAMAIAH:** It was sent to all the ships but those in the vicinity including the Teesta took part in the search.
