Grants to States for upgradation of prison administration

608. SHRI JANARDHANA POOJARY: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that Government supplement and release grants on the recommendations received from the Eleventh Finance Commission for upgradation of prison administration;
- (b) if so, the details of the funds received from EFC, supplemented by Government and released to the State Governments during the last three years, year-wise and State-wise;
- (c) whether it is a fact that full grants have not been released to some States; and
- (d) if so, the details thereof and the present status in this regard and the targeted date for settlement of the claims?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI MANIKRAO GAVIT): (a) to (d) The Eleventh Finance Commission has recommended a grant amounting to Rs. 116 crore for upgradation of the existing arrangements for security in the prisons and for vocational training and medical facilities for the inmates for the period 2000—05. The amounts released to the State Governments from 2000-01 to 2.12.2004 is Rs. 74.56 crores. The details of the amounts released year-wise and State-wise for the period 2000-01 to 2004-05 (till 2.12.2004) are indicated in the enclosed Statement (See below).

The States were required to furnish copies of the action plan, duly approved by their State level Empowered Committee for receiving these grants. Certain other conditionalities like submission of administrative approvals, utilization certificates in respect of grants released, completion certificates have also been imposed, which the State Governments are required to fulfil for release of these grants to them. The grants recommended by EFC are to be utilized by the States by 31.3.2005 and any unspent balance on that date will not lapse and will be credited to the Incentive Fund as recommended by the Eleventh Finance Commission.

Regrouping of ULFA in Bangladesh

- (c) the ULFA and the anti-Indian Jehadi organisations in Bangladesh joined hands; and
- (d) if so, whether ULFA would be proceeded against as an anti-national organisation?
