THE MINISTER OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOP-MENT (SHRI K. K. SHAH): (a) and (b) The Delhi Development Authority have advised that comprehensive measures should be taken to curb the pressure of in-migration into Delhi and to reduce the pressure of population on Delhi by preventing the location of new offices in the Capital and moving such offices as can effectively function from outside Delhi to other parts of the country. The whole question is under Government's active consideration; it has, of course, been the objective, since some years, to move out of Delhi, offices that need not function here and some results have been achieved.

OUT-OF-TURN AI LOTMENT OF GOVERNMENT ALCOMMODATION

*445. SHRI CHITTA BASU: Will the Minister of HEALTH AND FAMI-LY PLANNING AND WORKS, HOUSING AN DURBAN DEVELOP-MENT be pleased to state:

- (a) whether it is a fact that Government employees who were sanctioned out-of-turn allotment of Government accommodation in Delhi in 1967 on medical grounds have not been allotted quarters so far whereas others who were sanctioned on the same basis subsequently, have already been allotted houses:
 - (b) if so, the reasons therefor;
- (c) whether it is also a fact that fresh out-of-turr allotments on medical grounds are being made on ad hoc basis whereas the old sanctioned cases are still lying pending; and
 - (d) if so, the reasons therefor?

MINISTER OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN (SHRI K. **DEVELOPMENT** K. SHAH): (a) and (b) A number Government em loyees were sanctioned out-of-turn allotments of Government accommodation in 1967 on medical grounds. As the allotments in such cases were to be made within the quota prescribed for the purpose, many these sanctions emained unsatisfied for long periods. I ater, on account of the over-all shortage of residential accommodation in Delhi, a ban was imposed on fresh applications with effect from 17th May, 1968. The matter was re-examined in May, 1969 and it was decided to review all the pending sanctions, as it was felt that, with the passage of time, there might have been changes in the ircumstances in which sanctions had been issued. On basis of the information called for in

connection with these cases and otherwise, a number of them were reviewed and appropriate further decisions were taken to confirm or modify the previous approvals. The cases in which the required information is still not available or in which it has been found necessary to call for further information are still to be reviewed. For this reason, it is possible that a person junior according to the original sanction might have got an allotment earlier, it having been possible to review his case earlier.

(c) and (d) There was a ban on entertaining fresh requests for out-of-turn allotments up to 30th September, 1970. However, requests for such allotments on medical grounds in exceptional circumstances were placed for consideration before a Special Accommodation Committee constituted for this purpose and for reviewing past approvals. Pending sanctions for out-ot-turn allotments are being dealt with as explained above.
