## INCIDENTS IN IMPHAL

- 1114. SHRI GOLAP BARBORA: Will the Minister of HOME AFFAIRS be pleased to
- (a) whether it is a fact that some unhappy incident leading to assaults, arson and loot etc. took place at the main market of Imphal in the evening of 1st November, 1970; and
- (b) if so, whether allegations made by the Press and local organisations, about the total callousness of the police at the initial hours have been enquired into and if so what action has been taken against negligent police officers?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K.C. PANT): (a) According to information received from the Government of Manipur. there were several incidents of violence and attacks on shops in the Imphal Bazar on November, 1, 1970 after 7 P.M., following the alleged molestation of a woman. The police had to use tear-gas to disperse crowds of miscreants. By about 9.30 P.M. the situation was reported to have been brought under control.

(b) An allegation was made that the police pickets posted in the bazar area had failed to act on the first signs of trouble. On a summary inquiry one sub-inspector and two assistant sub-inspectors of police were suspended. The Deputy Inspector General of Police has been directed to undertake detailed enquiry.
