

**PAYMENT OF ROYALTY CESS  
BY MINE OWNERS**

**1328. SHRI KALYAN ROY :  
SHRI BHUPESH GUPTA :**

Will the Minister of PETROLEUM AND CHEMICALS AND MINES AND METALS be pleased to state :

(a) whether Government are aware that the work of the Asansol Mines Board of Health has been early paralysed because of the failure of the mine owners to pay their Royalty cess on the basic of tonnage of output;

(b) what is the amount of Royalty cess due from the mine owners in 1967-68 and 1969-70 and amount collected so far;

(c) the names of the coal mines which have not paid Royalty cess in 1967, 1969 and 1970 and amount due from each one of them and what steps have been taken to collect the amount and the results thereof; and

(d) whether Government are taking any steps to improve the functioning of the Asansol Mines Board of Health and if so, the details thereon?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI NITI RAJ SINGH CHAUDHARY) : (a) and (b) Early in the current financial year, the financial position of the Board was reported to be not satisfactory primarily due to the fact that the Board, which wanted to levy fee from the owners of mines at an enhanced rate with effect from 1970-71, could not collect the fees in time, since, for such enhancement certain formalities, including State Govt.'s approval, had to be gone through, which took some time. No royalty cess is collected by the Board from the mine owners with effect from 1st April, 1966. However, the amount of fees due and collections there against, in 1967-68 and 1969-70, were as follows:—

(c) A list giving the names of the collieries and the amount outstanding against each one of them as on 31st March, 1970 is attached. [See Appendix LXXIV, Annexure No. 82] Wherever necessary, certificate

proceedings are instituted against the defaulters for the recovery of arrears.

(d) The affairs of the Board were earlier regulated by the Bengal Mining Settlement Act, 1912. This has since been repealed and replaced by the West Bengal Settlements (Health and Welfare) Act, 1964, which was enforced within the Asansol Mining Settlements with effect from 1st April, 1966. Under this Act, no royalty cess is leviable. The State Government are considering a proposal whether the Board can be given any financial assistance in lieu of the loss suffered by the Board due to the abolition of the Royalty Cess.
