CHARGING OF DIFFERENT! M RATES OF INTEREST BY NATIONALISED BANKS

94. SHRI THILLAI VILLALAN : SHRI BIRA KESARI DEO : DR. B. N. ANTANI :

Will the Minister of FINANCE be pleaded to state :

(a) whether there is any proposal under Government's consideration to charge differential rates of interest by the nationalised banks from different categories of borrowers, especially low rates of interest from the poorer and weaker Section of the society;

(b) if so, what arc the details in this regard; and

(c) what is Government's assessment of the impact thereof on other sections of borrowers, particularly industrialists ?

THE MINISTER OF REVENUE AND EXPENDITURE IN THE MINISTRY FINANCE (SHRI VIDYA CHARAN SHUKLA) : (a) to (c) At the meeting of the Finance Minister with the chief executives of the public sector banks held that credit may be made available at cheaper rates of interest to selected categories of borrowers from the weaker sections of the society while (progressively higher rates might be charged from the affluent sections. In order to determine the criteria for identifying the borrowers who could be granted the benefit of lower interest rate within each sector and to work out the details of the scheme, a Committee has been constituted with Dr. R. K. Hazari, Dy. Governor of the Reserve Bank, as Chajrman. The Committee held its first meeting on the 17th October. 1970,

and is expected to submit its report within a period of three months. The impact of the proposed scheme on other sections of borrowers will be studied by Government and details finalised after the report of the Committee is received.

STRIKE BY SEA-FARERS BOMBAY

95. SHRI THILLAI VILLALAN : Will the Minister of PARLIAMENTARY AFFAIRS AND SHIPPING AND TRANSPORT be pleased to state :

(a) whether the sea-farers in Bombay resorted to any strike recently; and

(b) if so, what ar_e the details thereof?

THE MINISTER OF PARLIAMENTARY AND SHIPPING AFFAIRS AND TRANSPORT RAGHU (SHRI Κ RAMAIAH) : (a) and (b) The National Union of Sea-farers of Tndim, Sombay, a recognised Union sea-farers, resorted to boycott of signing on of crew for ships with effect from 6th October 1970 to voice their protest against the inclusion of Shri O. C. Mendes, a nominee of the Indian National Trade Union Congress, as a delegate representing sea-farers to the I.L.O. Maritime Conference held in Geneva in October 1970. The strike was called off on 15th October 1970. The number of ships affected by the strike was 11 at Bombay and 5 at Calcutta.
