THE MINISTER OF REVENUE AND EXPENDITURE IN THE MINISTRY OF FINANCE (SHRI VIDYA CHARAN SHUKLA) : (a) Rs. 1,200 crores.

(b) (i) A special plan of assurance is being introduced for rural areas where owing to seasonal variations in agricultural incomes policyholders experience difficulty in paying premiums regularly.

(ii) Special efforts are also being made to enlarge the scope and extent of group life insurance and to extend it to the less affluent sections of the population.

(c) There has been an increase of more than 50% in the Group insurance business transacted in the first six months of 1970-71, as compared to the corresponding period of 1969-70.
