Information i elating to the amounts advanced by the nationalised banks to newspapers, individually, cannot be furnished in view of the provisions of the Bankking Companies (Acquisition and Transfer of Undertakings* Act, 1970, which prohibit the banks from divulging any information relating t :> the affairs of their constituents! except in certain specified circumstances. However, the total amount of advances of such of the nationalised banks as are available, to newspapers as on last Friday of September, 1970, is indicated below:

As for the amounts so far recovered by the banks from the newspapers towards the loans advanced, since most of the accounts are in the form of cash credit and overdrafts, which are running accounts and fluctuate within specified limits, it is not possible to indicate the total amounts recovered.

HIJACKING OF PLANES

- *54. SHRI S. S. MARISWAMY: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:
- (a) whether Government have examined the implications of the increased incidents of hijacking of planes in which several Indians were also kept as hostages;
 - (b) if so, the details thereof; and
- (c) whether Government's attention has been drawn to a news-item published in the Indian Express dated September 12, 1970, to the effect that the Government of India were completely indifferent to hijacking incidents, and if So, their reaction in this regard?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH):
(a) and (b). Yes, Sir. Government views all such acts with deep concern since they constitute a grave hazard to persons on board an aircraft as well as on the ground. It has accordingly condemned all acts of unlawful interference with international civil aviation, including what is commonly known as hijacking. The Government of India has participated in international efforts towards evolving a suitable solution to the serious problem and will continue to do so. Security arrangements have been strengthened at our international airports.

(c) The news item in question does not reflect Government's views on the matter.

CAPITAL GAINS TAX IN RESPECT OF NATIONALISED BANKS

*55. SHRI BIRA KESARI DEO : DR. B. N. ANTANI:

Will the Minister of FINANCE be pleased to state:

- (a) whether there is any proposal under Government's consideration to exempt the fourteen nationalised banking companies from Capital Gains Tax in respect of the compensation amounts paid to them; and
- (b) whether the banking companies which prefer to take the compensation amount in bonds will also be exempted from tax on the interest in respect of the onds?

THE MINISTER OF REVENUE AND EXPENDITURE IN THE MINISTRY OF FINANCE (SHRI VIDYA CH \RAN SHUKLA): (a) No, Sir.

(b) No, Sir. The interest in respect of the Compensation Bonds would be liable to tax under the Income-tax Act, 1961.

FIXATION OF UPPER SALARY LIMIT

- (a) whether it is a fact that the All India Railwaymen's Federation has suggested the fixation of an upper salary limit of Rs. 2,500 so as to bring all incomes of Central Government emtiloyees within the ratio of one to ten; and
- (b) if s'o, what is Government's reaction in this regard?

THE MINISTER OF REVENUE AND EXPENDITURE IN THE MINISTRY OF FINANCE (SHRI VIDYA CH \RAN SHUKLA): (a) Yes, Sir. This suggestion has been made by the Federation to the Third Pay Commission.

(b) Government would await the recommendations of the Third Pay Commission.
