## DECLINE IN EXPORTS

Will the Minister of FOREIGN TRADE be pleased to state :

- (a) whether there has been a sharp decline in our exports especially to West Europe in 1969-70 and so far during the current year;
- (b) if so, the extent thereof and the reasons therefor; and
- (c) what efforts are being made to boost our exports?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (CHOWDHARY RAM SEWAK): (a) and (b) Yes, Sir. Though our global exports increased by Rs. 59 crores in 1969-70 as compared wi h 1968-69, exports to West Europe which stood at Rs. 338 crores during 1968-69 declined to Rs. 295 crores in 1969-70. During the current financial year (i.e. April to June, 1970 up to which statistics are available), exports to West Europe fell to Rs. 60 crores from Rs. 77 crores during the corresponding period of 1969. The decline has been mainly on account of lowering in India's exports to the British market of some of our raditional products such as tea, unmanufactured tobacco, cotton piece goods, jute goods and mixed vegetable oils.

(c) The steps proposed to be taken for securing an increased share of this market for our products have been outlined in the Export Policy Resolution which was laid on the Table of the House in the last Session of the Rajva Sabha. The results obtained will inevitably depend upon the manner and the extent to which these steps are implemented. Besides, new products mainly in the non-traditional sector and having good export potential in relation to the West European markets are being ii fied to offset the loss.
