Letters of intent ;wve also been granted to two parties ir the private sector for manufacture of i irs, for an annual capacity of 50,000 Njs. and 25,000 Nos. each based on indigerous, design and without foreign exchange expenditure on the import of capita goods, components and raw materials except in cases of raw materials normally available in the country which, in the event of temporary short supply, may ha' e to be imported in accordance with ihe import policy prevailing at that time.

It is hoped that with the establishment of the additional capacity, the supply position of passenger are in the country would ease over a period of time.

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOPMENT AND INTERNAL TRADE (SHRI M. R. KRISHNA) : (a) and (b) :

Government have received various communications making certain points and suggestions about the Cigarette Industry, but no demand for an enquiry as such ha"; been addressed. Suggestions made are being looked into.

#### **STRIKE IN BIULAI AND DURGAPUR STEEL PLANTS**

287. SHRI K. L. N. PRASAD: Will the Minister of STEEL AND HEAVY ENGINEERING be pleased to state :

(a) whether it is a fact that strikes and bundhs considerably affected productions at the public sector steel plants in August, 1970;

(b) what was the loss suffered by the Rourkela Steel Plant due to the Orissa bundh in luly. 1970;

(c) the effect of the recent heavy rains which dislocated transport and also the lightning strike by the staff of South Eastern Railway at the marshalling yard on the production in Bhilai Steel Plant; and

(d) what effect the Durgapur bandh on August 4. 1970 and the tool-down strike on August 6, 1970 and the illegal strike in the Durgapur Steel Plant and the Alloy Steel Plant on August 12, 1970, had on the production of Durgapur Steel Plant ?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRI MOHD. SHAFI QURESHI) : (a) Yes, Sir.

(b) Due to the Orissa bundh in July, 1970, there was loss of production to the extent of 14,974 tonnes of finished steel and of 1.237 tonnes of Calcium Aramo-niam Nitrate in the Rourkela Steel Plant

and the Fertilizer Plant at Rourkela. In financial tenuis, the loss amounted to about Rs. 33.20 million.

(c) The heavy rains and the lighting strike by the staff of South Eastern Railway did not affect production at Bhilai.

(d) The incidents mentioned in this part of the question resulted in loss of production at Durgapur Steel Plant to the extent indicated below :
