- (b) if so, what was the reaction of the Government of India to that proposal?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) Yes, Sir.

(b) The recent conflict in Jordan was in the nature of a civil war. It was Government's view that under the circumstances, outside interference would make the situation even worse and the most constructive approach to the problem was to counsel through diplomatic channels restraint and moderation on both sides.

# MANUFACTURE OF SPURIOUS **DRUGS**

1554. SHRI THILLAI VILLALAN Will the Minister of HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVE-LOPMENT be pleased to state:

- (a) the number of cases of manufacture of spurious drug tablets and capsules found recently;
- (b) in which of the States it was found;
  - (c) what are the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI B. S. MURTHY): (a) to (c) A statement containing the information is laid on the Table of the Sabha.

#### STATEMENT

The Government of Andhra Pradesh have intimated that no case of spurious drug tablets and capsules has been found in their State. But one case of spurious drug of Woodward Gripe Water Batch No. 782/M/70 allegedly manufactured by M/s Anglo Thai Corporation Ltd., Madras was detected and is under investigation by the State Government.

- 2. The Government of Maharashtra have stated that during 1969-70 no case of manufacture of spurious drug tablets or capsules was detected in the State. However, two cases of stocking for sale and distribution of spurious Bismuth Carbonate LP. were detected. The cases against the firms have been filed in Court of Law at Bombay. During 1970also no case of manufacture of 71 spurious drug tablets or capsules was detected in Maharashtra. However, three cases of spurious drugs were detected. These related to Saccharin LP., Flit and a case of misbranded Asquin tablet. Necessary action against concerned firms is being taken by the State Government.
- 3. A case of sale of spurious sulphanilamide powder has recently been detected by the Government of Rajasthan in which investigations are in progress.
- 4. The Government of Tamil Nadu have reported two cases in which Bismuth Carbonate (spurious) labelled and repacked by M/s Medi-Pharma Drug House. Bombay-9 and by M/s Wasons Drug Laboratory, Bombay-2 have been found. The investigations in these cases are in progress.
- Delhi A. 7,300 5. The Administration possession chloramphenicol capsules which were suspected to be misbranded. The sample has been sent to Government Analyst and his report is awaited. Besides the above, the fol lowing drugs were also taken into possession by the Delhi Administration which were also suspected to be not

The samples of t lese drugs have been sent to the Gove nment Analyst. Reports of two samp es have been received and they have 1 een found not of standard quality; nd misbranded. *I* he reports on other samples are awaited.

- 6. One case of circulation of spu-Tious drug "Chloremphenical" Capsule, bearing the label 'U.S.P. CH 197" manufactured by Associated pharma, Rajouri Garden, Delhi was detected by Himachal Pradesh Government in 1969 and the case has been launched in the Court of Law.
- 7. The State G Ivernment of Assam, Bihar, Gujarat, Ilaryana, Kerala, Mysore, Orissa, Pun ab and West Bengal and Union Territories of Andaman and Nicobar Islands, Tripura, Chandigarh, Goa. Daman and Diu. Manipur Dadra and Nagar Haveli and Pondicherry have reported that no case of manufacture of spurious drug; has been detected (recently). The i iformation from the remaining States thd Union Territories lias not been reo ived.

- (e) whether the father of the deceased was also called in the course of the inquiry, and if so the nature of the discussions held in that connection?

MURTHY): (a) A preliminary Inquiry has been conducted by the hospital authorities into the circumstances leading to the death of a nine years old child named Prem Kumari in the Willingdon Hospital on the 23rd April, 1970
