PLANNING COMMISSION'S IMPACT ON GOVERNMENT POLICIES

529. SHRI K. L. N. PRASAD : Will the PRIME MINISTER be pleased to stage:

(a) whether it is a fact that after a spell of hibernation, the Planning Commission has started more active role towards making an impact on Governmental policies;

(b) if so, whether it is a fact that a full meeting of the Commission was held in October, 1970 to review the state of the country's economy and anticipate the strains and stress to which it would be subjected in the coming six months;

(c) if so, what decisions were taken in the meeting; and

(d) how far Government have accepted and implemented them ?

THE PRIME MINISTER AND MI-NISTER OF PLANNING (SHRIMATI INDIRA GANDHI) : (a) to (d) A full meeting of the Planning Commission was held on the 7th October, 1970. A statement indicating the subjects discussed at the meeting and decisions taken is laid on the Table of the House.

STATEMENT

I. Industrial situation.—The Planning Commission reviewed the present industrial situation and considered what modifications in procedures, within the policy framework laid down by the Government, could be suggested to accelerate industrial development. The review indicated that on present trends substantial shortfalls might occur in the targets in key industries like steel, fertilisers, etc. To ensure achievement of targets of production in the key sectors, it was agreed that the issues should be further discussed by the Planning Commission with the Union Ministries and State Governments. These discussions would be held shortly.

II. Financial assistance from institutional agencies.—In the light of the recent Government decision to allow public sector companies to approach the financial institutions for funds, it became necessary to evolve procedures which would help maintain Plan priorities. It was decided that the Planning Cofhmission should take action to ascertain from the Ministries their proposals for new projects in the public sector sought to be financed by institutional agencies and consider them from the point of view of priority and via-

bility in consultation with the financial institutions and the Finance Ministry in the light of a resh assessment of resources of the financial institutions. So far as the proposals fron the States were concerned, it was agreed I hat the financial institutions would refer proposals to the Planning Commission or guidance about their priority.

III. Scrutiny and sanction of Plan projects.—One of the major reasons for delay in the implerm ntation of the public sector projects was the considerable time taken in the pre-comtruction stage. Inadequacy in preparation and advance planning of projects often ted to delays in their scrutiny and sanction. It was considered that technically mannei Planning Cells should be set up in the Ministries to ensure the preparation of projects in sufficient detail. Also the officers of the Finance Ministry should be associated at the time of preparation of the feasibility reports and detailed project reports so that the relevant considerations were brought to the notice of the project authorities right at the time of the preparation of the feasibility reports/D.P.Rs. To look into the problems of o^e^all coordination and progressing in the industrial sector, it was decided to improve the mechanism of Coordination. Srecial attention was to be paid to the ir creasing of industrial production, develo ment of medium and small industries, interjation of small-scale industries with ligrep-scale industries with ligrep-scale industries through an arrangemem by which the latter would shed the manufacture of components and ancillaries in 1 wour of the former, and formulation of model schemes on an ex-perimental basis for the development of employment or analysis employment or enled small-scale industries in selected backward districts. Steps are being taken to concretise the programme and procedures

IV. Measures to tackle the problem of unemployment-- Various measures and the directions in v hich the problem of unemployment ct uld be tackled were discussed. In thi: context the need for an integrated District/State Plan was stressed. It was agreed I hat a beginning should be made by orgarising pilot programmes in each district on an urgent basis, having employment potential for a minimum specified number ol people. In pursuance of this decision steos are being taken to evolve a suitable proframme of action and to put it into operation.

VI. Resources of States.—The Planning Commission reviewed the resources position of the States and the efforts being made by them to mobilise resources for the Fourth Plan. The Commission are having detailed discussions with the State Governments on the resources position of each State in the context of the formulation of the Annual Plan for 1971-72.
