traditional. Sanskrit devotional compositions are included in the programme. It is not proposed to change the present pattern of programme.

Written Answers

LISTENERS PROGRAMME

574. SHRI SANDA NARAYANAPPA; Will the Minister of INFORMATION AND BROADCASTING AND COMMUNI-CATIONS be pleased to state:

- (a) whether Government have conducted any survey to find out the number of listeners of programmes "Kheti-ki-Baten", 'Tamil Path' and 'Sangeet Path' broadcast over the All India Radio from Delhi;
- (b) whether Government have also conducted a survey to find out the benefit derived by the listeners from these programmes; and
 - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS (SHRI I. K. GUJARAL): (a) A survey in Delhi City was conducted to find out listening to Delhi Station's programmes, including 'Khetiki-Baten', 'Sangeet Shiksha' and 'Tamil Path.' No separate survey, however, is undertaken specifically for these three programmes.

- (b) A study was made in three villages around Delhi to find out the extent of modern methods of farming used and the part played by information agencies including radio 'in dissemination of relevant information. No study has, however, been made of the benefit derived by listeners from 'Sangeet Shiksha and Tamil Path'.
- (c) The major findings of the study conducted in three villages around Delhi are :--
 - (i) Farmers in these three villages increasingly adopted modern methods of agriculture particularly in seeds and fertilizers but fewer of them used plant protection methods, deep sowing, etc.
 - (ii) Radio has been a fairly good source of information though the Village Level Worker remains the most important source.
 - (iii) Most of those who listen to the radio, generally listen to rural programmes as well; 98 per cent at Hastal, 100 per cent at Surera and 91 per cent at Jharoda.
 - (iv) With the increase in domestic radio sets and installation of community T.V. sets, community listening in chopals, etc. is on the decline.

RAT FOUND IN THE BOTTLE OF D.M.S. MILK

575. DR. SALIG RAM: SHRI ARJUN ARORA: SHRI KRISHAN KANT: SHRI RAJENDRA PRATAP SINHA:

Will the Minister of FOOD AND AGRI-CULTURE be pleased to state:

- (a) whether the attention of the Government of India has been drawn to the report that a rat was found in the bottle of double tonned milk supplied recently by Delhi Milk Scheme; and
- (b) if so, what action has been taken in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) Yes.

(b) The Government have taken a serious view of this incident. The Chairman, D.M.S. has been asked to issue strict instructions to the staff employed on bottling lines just before the bottles are filled with milk and capped to ensure that no bottle containing any foreign matter is filled with milk. He has also been asked to take strict disciplinary action against the officials at fault in such cases.
