- (a) whether any complaint was received by hi m from D'. Rabindra Nath Das Gupta of the Delhi University against harassment by the railway officers at the New Delhi railway station and the charging of double fare from Hi wrah to New Delhi;
- (b) whethei Dr. Das Gupta had given evidence of hi lost tickets by citing ticket numbers, re.sc vation of chaiis and also the luggage s ips before he was charged the double fa
- (c) whether the double fare charged from *Dc*. Das Gupta has been refunded since his rep: sentatiori in the matter; and
- (d) if the money has not been refunded to him so far what are the reaons there for ?

THE MIP tSTER OF RAILWAYS (SHRI GUL':ARILAL NANDA): (a) Yes, Sir. Bi t ihe complaint was from Dr.R.K Das 'iuptaandnotDr. Rabindra Nath Das Gu .la.

- (b) Shri D.i. Gupta d'd argue about his name and the name of his wife being included in the reservation chart which mentioned ticket numbers, reservation ticket number: and luggage ticket numbers and also referred to the fact that th^j staff accompanying his train were satisfied that he had re dly bought the tickets. However, sin<e lie was not in possession of any tickets he staff at the station could only show him the consideration of charging the single fare without any penalty.
- (c) Yes, 'Sir. The fare collected at New Delhi ha< been refunded after deducting the cancellation fee and money order commission. However, the deduction of cancellation fee is not in order in this Case and instructions are being issued for the further refund of the amount so deducted.

PROGRAMS E OF NATIONALISATION

*J86. DR. I;HAI MAHAVIR: Will the Minister of INDUSTRIAL DEVELOP-MENT AND INTERNAL TRADE be pleased to state:

- (aj whether Government s attention has been drawn to a speech by the Defence Minister at Chandigarh on October 19, 1970 wherein he is reported to have said, that he "was no' satisfied with the programme of nationalist on" and that "in the name of public sector, capitalist conliol had been replaced by bureaucratic control which did not mean nationalisation in any form"; and
- (b) if so, what is the reaction of Government to the views expressed by him; what steps, if any, Government propose to take in the matter?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND INTERNAL TRADE (SHRI DINESH SINGH): (a) and (b) A statement is laid on the Table of the House.

STATEMENT

- (a) Government have seen the press reports in this connection. It is, however understood that the. Defence Minister speaking in his capacity as President of the Indian National Congress, had, while dealing with working cl; ss movement in his inaugural address to the cadre-building training camp of Congress workers at Chandigarh on October 19, 1970 said that in nationalised undertakings there was no distinction of employers and employees. All engaged in such undertakings were the emp'oyees of the State of the nation. There should, therefore be no occasion for a conflict in nationalised undertakings as in private sector. All should cul'ivate a sense of belonging and involvement and see to the progress of the undertakings. Any tendency to merely substitute capitalist control by the control of a set of officials would not be in keeping with the spirit of nationalisation.
- fb) Government are in agreement with the view as given above.

REFUND OF MONEY COLLECTED BY RAIL-WAYS AS PILGRIM TAX

- ♦287. SHRI DEVDATT KUMAR KIKABHAI PATEL: Will the Minister of RAILWAYS be pleased to state:
- (a) whether it is a fact that the Chanol Gram Panchayat in Gujarat has been refunded the money which was cillected by the Railways in the past as pilgrim tax;

- (b) if so, how much amount has been refunded till date ;
- (c) winther it is also a fact that "Unai Gro Gram Panchayat" (Gajarat) have recently demanded from the R if ways the amount collected by Railways as a Pilgrim Tax from "Unvi and Bansda Road Stations on the Western Railway";
- i) if so, the action taken by Governman thereon ?

THE MINISTER OF RAILWAYS (SHRI GULZARILAL NANDA) : (a) and (b) A sum of Rs. (7.)00 25 was collected as Pilgrim Tax from passengers booked to and from Chan lod Ruhvay station during 1-8-49 to 31-7-53 when the tax was discontinued. After deduction of collection charges, Rs. 44.943.71 were credited to the Accountant General of the thea Government of Bombay. The further disposal of this sum by the Bombay Government is not known to the Railway. Ministry.

(c) Yes.

(d) Unai Gram Panchayat has been replied by the Western Railway that the Rulway Alministration had collected Rs. 24.259/10/3 towards the pilgrim tax at Unai and Banada road rations during January, 1950 to 20-10-1954 when the tax wir discontinued and our of this amount Rs. 23,046/10/3 were aredited to the then Government of Bombay after deducting collection charges. The Panchayat has been further advised to approach the Government of Maharashtra for further action in this regard.

FEUDAL STRUCTURE OF INDUSTRY

*288. DR. DEBIPRASAD CHATTO-PADHYAYA: Will the Minister of INDUSTRIAL DEVELOPMENT AND INTERNAL TRADE be pleased to state whether there is any proposal under Government's consideration to break up the feudal structure of industry and the various business houses?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND INTERNAL TRADE (SHRI DINESH SINGH) : A statement is laid on the Table of the House.

STATEMENT

Gorman and basic policy in respect of indistrial development is to bring about an acceleration in the rate of industrial

growth to the maximum extent possible so as to provide gainful employment opportunities and improved living standards and working conditions for the masses. At the same time, it is considered escential that disparities in wealth and income should be reduced and that monopolistic practices and concentration of economic power and control over mean of production in the hands of a few ting by or business groups should be on bed as far as possible. The abolition of the intringing agency system, the nationalisation of 14 major banks and consequently accordentation of banking and credit policies, the unolementation of the Monopolies & Restrictive Trade Practices Act and recent changes in licensing policy are steps in this direction. The new licensing policy envisages substantial liberalication for small and medium entrepreneurs as also encouragement to new entrepreneurs. The role of the public sector is also proposed to be expanded to cover areas of major production gaps as are likely to emerge, small scale industries and medium industries are also being encouraged to plan a more effective, role in the industry. It is expected that as a result of all these measures, the proportionate conventration in the hands of family business groups will be gradually reduced and that, along with a much wider entropic mind base, greater emphasis will be taid on profesional management. The economic trend; and developments in the country are under constant watch and such additional measures as are considered necessary will be adopted to achieve the above basic objectives.
