- (6) Other terms and conditions.—(a) the duration of the course should not exceed 2 to 3 years.
- (b) the student will have to provide guarantee of the parents/guardian or a third party.
- (c) the student is also required to take out an endowment Life Insurance Policy on his own life for a sum equi-

valent to the amount of the Loan; and assign the policy to the bank. In the even of the student not being able to pay his premium out of his own resources, the premium will be paid from the loan amount.

TRANSPORT (SARDAR IQBAL SINGH): (a) and (b) The Joint Steamer Companies were operating river services from IT.P. and Bihar to Calcutta on the Ganga and from Calcutta to Assam on the Itrahmaputra. In 1958, the services on the Ganga were closed for a number of reasons including lack of traffic. Certain experinental river services with shallow draft vesels were run during 1960-62 on the Gan;a. These proved their technical feasibi ity but had to be discontinued on accomt of inadequate traffic. Due to hostilities with Pakistan, the river route from Calcutta to Assam was also closed. However with the completion of Farakka Barrag I an all-India route from Calcutta to Bih; r and U.P., via Hooghly-Bhagirathi Gania can result throughout the year. A t-affic study to assess the quantum of traific likely to be offered to the river route after the completion of Farakka Project is in progress. The question of running river services can be considered after the receipt of the above report and completion of Farakka Barrage Pro-ject-1
