SARDAR SWARAN SINGH: Not to my knowledge, Sir.

SHRI M. K. MOHTA: May I ask the hon. Minister whether, pending the result of the enquiry, some preventive action would be taken by the Government to prevent other girls from going outside and a doubt being created later on that some money may have passed in their respect also? What kind of preventive action would the Government take for the future?

SARDAR SWARAN SINGH: Sir, I do not know what preventive action can be taken. They are Indians, they are grown-up men and women; they are free to go anywhere they like. I cannot impose travel restrictions on persons whether they are men or women, who want to go abroad. If there are any underhand methods being employed, they have to be countered. So, the preventive action is to ensure that. If anybody wants to go, he or she goes of his or her free will, and that is what we are ensuring now.

MR. CHAIRMAN: I think that question has been answered.

SHRI LOKANATH MISRA: May I know whether the travel abroad of 57 girls was not cancelled roundabout the 30th August after this debate particularly in both Houses of Parliament? And may I know what is the attitude of the Central Government towards this particular aspect of the matter, whether they are of the opinion that since this helps some of the girls in going abroad and getting jobs, why should public men shout against it? Is that what the hon. Minister said somewhere, may be in the other House, may be elsewhere? Is that the attitude of the Government that there should not be any bar to these girls being sent abroad, whether they are sold or not?

SARDAR SWARAN SINGH: Part of the question can be answered by those Members whom he says are shouting. We are not shouting. We are looking at this problem in a very dispassionate manner. I have already said that those girls... (Interruptions) I have not used the word. Your colleague has used that, with whom you are forging an alliance now. I have...

SHRI LOKANATHA MISRA: Sir, he did not understand the question at all. The basic approach of the Minister to the question that I ask... SHRI LAL K. ADVANI: Sir, this is very bad. मभापति जी: स्राप को स्मर्ण होगा कि पहले भी कई बार जब उन्होंनें उत्तर दिया है ये कोई न कोई स्रपमानजनक वात कह देते हैं। वह सीधा सा सवाल पूछ रहे हैं स्रोर यह हम पर इंगू नियेशन करने हैं, यह गलत बात है।

SHRI LOKANATH MISRA: Sir, my question was...

MR. CHAIRMAN: I have understood your question.

SHRI LAL K. ADVANI: Sir, can he not speak without being offensive?

SARDAR SWARAN SINGH: I was saying that the general approach is in consonance with what the hon. Member says that any person wanting to go abroad of his own free will, of his own volition, should be allowed to go, and we do not object to that. It is only in those cases when allegations are made that some unconscionable means were adopted in arranging the sending of some guls that there was discussion on the floor of this House and an inquiry has been initiated. So far as the general question of the freedom of everybody to go abroad is concerned, if they are going for normal purposes, there is no objection at all. I agree with you.
