Rule 3 of the All India Services (Discipline & Appeal) Rules, 1969 enables suspension of a member of the service against whom an investigation, inquiry or trial relating to criminal charge is pending, at the discretion of the Government, until termination of all the proceedings relating to that charge, if the charge is connected with his position or is likely to embarrass him in the discharge of his duties or involves moral turpitude. The Government under whom the officer is serving can exercise the said power. Further, suspension is required to be reviewed at specific intervals by a Committee as provided in the rules. During the period of suspension, officers are entitled to subsistence allowance at the rate of 50% of last pay for the first three months and thereafter at the rate of 75%, without the officer performing any duties. Besides, Criminal cases take a long time to conclude. The Review Committee makes recommendations to the Competent Authority for extension of suspension/revocation of suspension after taking into consideration the facts of each case.
