RISE IN PRICE OF RAW COTTON 846. SHRI N. P. CHAUDHARI: SHRI I. G. DESHMUKH: SHRI A. G. KULKARNI:

Will the Minister of FOREIGN TRADE be pleased to state:

- (a) whether there is an enormous rise of price in th. raw cotton available in the textile industry which has affected the profitability of the industry in general and adversely affected the growth of exports;
- (b) whether it is also a fact that it is ultimately likely to affect the employment position in the textile industry; and
- (c) if so, what are the salient features of the scheme to help the textile industry?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE

(CHOWDHARY RAM SEWAK): (a) There has been a rise in the prices of cotton during the recent weeks. It is difficult to say whether profitability of the industry has been adversely affected.

(b) and (c) The present situation is being studied with a view to taking corrective action. Efforts are being made to accelerate shipments of imported cotton already released. With larger arrivals in the market, the situation is likely to improve.
