

**ABOLITION OF WHEAT ZONES**

Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) whether it is a fact that the Chief Ministers at the National Development Council Meeting held in March, 1970 have favoured the abolition of wheat zones in the country; and

(b) the reaction of the Union Government thereto and whether any final decision has been taken in this regard ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE) : (a) The Chief Ministers and Food Ministers of rabi States met on 22nd March, 1970 after the Meeting of the National Development Council to discuss rabi policy for the 1970-71 season- The consensus of opinion at the conference was that, the entire country excepting the statutorily rationed areas be made one zone in respect of wheat.

(b) The entire country (excepting the statutorily rationed areas in Maharashtra and West Bengal States) has been made one zone for wheat, with effect from 4th April, 1970.

"Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) whether it is a fact that ever since its inception there has been no regular, properly qualified and duly selected Principal in the Institute of Hotel Management Catering and Nutrition New Delhi;

(b) whether as a result of this, Mr. V. K. A. Menon who had gone abroad at Government expense for higher training, left his post to join private service;

(c) whether a new person has\* been appointed in a scale higher than the original grade and the post is being upgraded for him without advertising it properly, although he has no teaching experience;

(d) whether it is also a fact that a number of officers of the Department of Tourism have been appointed part-time lecturers though they have no teaching experience or academic background; and

(e) if so, what steps are being taken to set the things right ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE) : (a) No, Sir. Difficulties have however, been experienced in selecting a suitable incumbent to the post from time to time.

(b) No, Sir. Shri Menon left his post as Vice-Principal of the Institute to improve his prospects.

(c) The present incumbent who fulfilled the prescribed qualifications was appointed on the basis of selection in response to open advertisement in the Press. It was stated in the advertisement that the salary would be fixed on merits. Pending fixation of suitable scale for the officer, he was appointed on his grade pay plus deputation allowance as admissible under the rules.

(d) An Officer of the Department of Tourism who is incharge of training in that Department was appointed as part-time lecturer for "Tourism" which is one of the subjects for study.

(iii) The recognized diplomas in one of the specified Engineering disciplines.
