RADIO MANUFACTURING INDUSTRY

297. DR. BHAI MAHAVIR: SHRI LAL K. ADVANI:

Will the Minister of INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS be pleased to state:

- (a) whether Government have taken a decision not to permit foreign collaboration in industries in which the country is self-reliant;
- (b) if so, when the decision in this regard was taken;
- (c) whether Government consider radio manufacturing industry to be a self-reliant industry;
- (d) whether Government have received applications from any parties for collaboration in radio manufacture; and
- (e) if so, the decisions taken there-on?

THE MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) and (b) It has always been Government's policy not to allow foreign collaboration in an industry if the requisite technology is indigenously available.

- (c) Yes, Sir. 'Commercial radio receivers' industry is included in the list of industries where no foreign collaboration (financial or technical) is considered necessary.
- (d) and (e) After it was decided that no foreign collaboration be permitted in radio manufacturing industry, no specific proposals for undertaking manufacture of radio receivers with foreign collaboration have been received. After this decision, all expansion proposals from existing manufacturers, who were making radios on the basis of arrangements involving royalty payment, were approved with the specific condition that for the expanded capacity, no royalty payment would be made.

INCREASE IN PAPER PRICES

298. DR. BHAI MAHAVIR: SHRI LAL K. ADVANI:

Will the Minister of INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS be pleased to state:

(a) whether Government's attention has been drawn to the resolution pass-

- ed by the Federation of Paper Traders Association of India in their annual conference held in December, 1969 alleging that some paper mills have increased the prices of paper through the subterfuge of a slight change in labels; and
- (b) if so, in view of the statement made by the Minister in Parliament to the effect that he had warned the mills against any further price increase, what steps Government have taken in the matter?

THE MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) Yes, Sir.

- (b) An Ad-hoc Committee on Paper has been constituted consisting of the representatives of the Government, Paper Manufacturers, Paper Traders and Consumers to look into the complaints about over-charging, change in the nomenclature, shortage of paper, and other malpractices and to suggest ways and means of eliminating these. At its meetings held on 17th & 18th April, 1970 at New Delhi and on the 23rd April, 1970 held at Calcutta, the Committee took the following decisions which were accepted by the Paper Industry and Trade.
- 1. The production of light-weight paper (56 GSM) will be maximised by the Paper Mills in the country in the coming two to three months so that all essential educational requirements for writing material and text-books in the coming season are fully met.
- 2. The Paper Mills will make available an extra quantity of 5000 tonnes per month during the next three months of the light-weight paper (56 GSM). This will be in addition to the normal supplies.
- 3. The Paper Industry would set up a Cell at its Headquarters at Calcutta to look into all genuine complaints about quality, over-charging, shortage of supplies and other allied malpractices.
- 4. The representatives of the Traders assured that they would also take all necessary steps against any malpractices in the trade and set up a cell to attend to the complaints in this regard.
- 5. The Committee would meet periodically and, for the present, they will

hold monthly meetings to review the position about paper supplies from time to time and to ke appropriate decisions to remove the cluses of complaints wherever required.
