THE DEPUY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (PROF. STDDHE-SHWAR PRAS/D: (a) 2670 villages have been electrized up to 31st March, 1970.

(b) Since 1965-67, the rural electrification schemes in the State of West Bengal and in o her States have been reoriented with ? bias towards energisation of agricultural pump-sets. In West 4—29 R.S.^0

Bengal 1291 tubewells/pumpsetg have been energised up to 31st March, 1970.

(c) From the State Plan ontlays, it is proposed to energise 1000 pumpsets/tubewells and electrify 300 villages in 1970-71 and energise 3000 pumpsets/ tubewells and electrify 300 villages during 1971-72. In addition funds would be provided by the Rural Electrification Corporation to the West Bengal State Electricity Board and other State Electricity Boards for rural electrification schemes with a bias towards energisation of pumpsets. So far the Rural Electrification Corporation have sanctioned Rs. 150.69 lakhs for electrification of 552 villages and energisation of 2309 pumpsets in West Bengal.

REPRESENTATION OF ENGINEERING OFFICERS IN CENTRAL WATER AND POWER COMMISSION

general principles laid down by the Ministry of Home Affairs for determining seniority of various categories of officers belonging to Central Services are not applicable in the case of Class I and Class II officers of the Central Water and Power Commission. Their *inter se* seniority is determined under the rules which had earlier been framed by the Ministry of Irrigation & Power in consultation with the Ministry of Home Affairs. As a result of certain representations received recently, the matter is under review
