THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) to (c) Recommendation No. 16 (a) made by the Administrative Reforms Commission in its Report on Personnel Administration dealing with the subject is still under the consideration of Government.

(d) The decision will be taken by Government as early as possible.

BOYCOTT OF EXAMINATIONS BY LAW STUDENTS

704. **SHRI GANESHI LAL CHAUDHARY :** Will the Minister of EDUCATION AND YOUTH SERVICES be pleased to state :

(a) whether it is a fact that the law students of the University of Delhi boycotted examinations this year;

(b) if so, what are the reasons therefor; and

(c) what steps Government have taken to avoid such incidents in future?

THE MINISTER OF EDUCATION AND YOUTH SERVICES (PROF. V.K. R.V. RAO) : (a) Some students taking the examination on April 29, 1970 in Law of Taxation created disturbances and prevented some other students who were continuing to take the examination from doing so.

(b) The students complained that the questions set for the examination were outside the prescribed syllabus.

(c) The complaint of the students has been looked into by the Acting Dean of the Faculty of Law who has given the opinion that the questions were not outside the syllabus. It is for the University authorities to take action in such matters.

AIR SERVICE BETWEEN KOLHAPUR AND BOMBAY

705. **SHRI G. R. PATIL :** Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state :

(a) whether there is any proposal under Government's consideration for operating an air service between Kolhapur and Bombay through a private airlines company; and

(b) if so, the time by when this service is likely to be introduced?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH) : (a) and (b) Proposals from various private airline operators have been received for operating non-scheduled air services between Kolhapur and Bombay but the service is not likely to be introduced in the near future as the aerodrome at Kolhapur is at present not quite suitable for Dakota operations.

POLITICAL SUFFERERS WORKING AS TEACHERS

(a) whether it is a fact that the political sufferers, who are working as teachers under the Directorate of Education, Delhi, had applied for promotion seeking special preference on the count of their political sufferings and had attached copies of the relevant circulars of the Government of India in this regard; and

(b) whether it is a fact that no replies have so far been received by these teachers and if so, the reasons therefor?

(c) the number of incidents of armed paddy looting during the period from 1st September, 1969 to 31st November, 1969;

(d) the number of persons killed in mining accidents during the year ended 31st March, 1970; and

(e) the action Government have taken against persons who have been responsible for breach of law and order in the Asansol, Raniganj/Durgapur industrial belt?

(a) the total number of staff cars in his Ministry;

(b) the journey performed in terms of kilometers by these cars during the year 1969-70 and the number of kilometers covered by them during holidays ;

(c) the total number of kilometers covered in the aforesaid journeys performed by officers and staff of his Ministry, respectively;

(d) whether it is a fact that staff cars are used by high officials and that they are not available for staff even for official duty;

(e) whether it is also a fact that high officials use these cars for coming to their offices and going home from there and also use them at home during holidays; and

(f) if so, whether the drivers have been asked to record correctly the details of the journey performed by each individual?]

(ख) 11,339 किलोमीटर (जिसमें छुट्टियों के दौरान का 23,306 किलोमीटर भी शामिल है)

(ग) अधिकारियों के सफर का अलग अलग हिसाब बताना सम्भव नहीं है क्योंकि लाग-बुक में सभी प्रविष्टियों पर राजपत्रित अधिकारियों द्वारा हस्ताक्षर किये जाते हैं और ऐसे आंकड़ों के इकट्ठा करने में बहुत अधिक श्रम करना पड़ेगा जो कि प्राप्त परिणामों के अनुरूप नहीं होगा।
