

**STATEMENT OF G. WERNOR OF RAJASTHAN  
REGARDING CHANDIGARH**

Will the Minister of HOME AFFAIRS be pleased to state :-

(a) whether it is a fact that the Government of Rajasthan recently made observations to the effect that the price paid for Chandigarh was "much too high for Punjab"; and

(b) if so, the reaction of the Government of India in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) Yes, Sir.

(b) Although the decisions regarding Chandigarh and Fazilka areas were taken and announced at the same time, they were not based on the consideration that Fazilka area was the price for Chandigarh or *Vice versa*. Government, therefore, do not share the view expressed by the Governor.

**BAN ON ENTRY OF HIPPIES INTO THE COUNTRY**

**IAS OFFICERS OF MYSORE**

700. SHRI K. S. MALLE GOWDA : Will the Minister of HOME AFFAIRS be pleased to state

(a) whether it is a fact that the total authorised strength of IAS Officers for Mysore State is 69 out of which the direct recruitment posts are 141;

(b) whether there is also a fact that there is no adequate representation for the Backward Castes and Scheduled Castes in the IAS Cadre; and

(c) whether there is any proposal for increase of the quota of State Promotees to these Services?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) Yes, Sir.

(b) There is no reservation in the LAS. for Backwards Classes. The reservation in favour of Scheduled Caste and Scheduled Tribe candidates in the I.A.S. is made (a-12 1/2% and 5% respectively of the vacancies to be filled through the Combined Competitive Examination; reservation 18 made on an all India basis and not State-wise. During the past few years they are being recruited upto the number of vacancies reserved for them. Out of them a proportionate number is being allotted to Mysore.

(c) A recommendation of the A.R.C. to increase the promotion quota to Class I Services including All India Services is under examination.
