- (b) There is no reservation in the I.A.S. for Backwards Classes. The reservation in favour of Scheduled Caste and Scheduled Tribe candidates in the I.A.S. is made @ 12 1/2% and 5% respectively of the vacancies to be filled through the Combined Competitive Examination; reservation is made on an all India basis and not Statewise. During the past few years they are being recruited upto the number of vacancies reserved for them. Out of them a proportionate number is being allotted to Mysore.
- (c) A recommendation of the A.R.C. to increase the promotion quota to Class I Services including All India Services is under examination.
