(b) whether it is a fact that Shri S. K. Bhattacharya falsified his records and furnished wrong and incorrect information regarding his date of confirmation in Class I post as Deputy Labour Commissioner to the U. P. S. C. ; and

(c) what action the Government propose to take regarding this selection ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) No, Sir.

(b) No, Sir. It was through an inadvertent error on the part of the Secretariat that the date of the permanent appointment of Shri S. K. Bhattacharya to a Class I post was shown wrongly in the records placed before the Selection Committee. This error was detected subsequently and pointed out to the Union Public Service Commission, when the proceedings were forwarded to them for ratification of the selection.
