position to absorb a substantial percentage of the income generated in the rural areas. Such a programme could be taken up only by providing adequate credit support from the banks to a large net-work of retail agencies instead of by a small number of miniature super bazars. The question of appropriate action necessary to meet the dimensions of the problem is separately under consideration of the Government.
