The current indigenous production of tractors is of the order of 18,000 to 20,000 tractors per year, whereas the estimated demand is 70,000 Nos., in 1970-71 going up to 90,000, i,n 1973-74 it is not possible to bridge the wide gap between the production and the demand by the end of 1970.
