## SUPPLY OF BILLETS TO THE ROLLING MILLS IN INDIA

812. SHRI THILLAI VILLALAN : SHRI KANCHI KALYANA-SUNDARAM :

## SHRI T. K. SRINIVASAN:

Will the Minister of STEEL AND HEAVY ENGINEERING be pleased to state:

- (a) whether Government have changed their policy in regard to the supply of billets to the Rolling Mills in India; if so, what is the change in the policy; and
- (b) whether Government are aware of the closing of Units and retrenchment in the Rolling Mills in Tamil Nadu; and
- (c) if so, what steps Government propose to take in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRI MOHD. SHAFI QURESHI): (a) It has been the practice to review the distribution policy of billets from time to time, taking into account new factors and changed circumstances. Such a review was recently completed and the new policy communicated to the Joint Plant Committee. The main changes between the billet distribution policy as it was immediately before the announcement of the current policy and the current policy is that the quota for export of bars and rods has been reduced while special allocations have been made for the production of twisted deformed bars and other difficult sections.

(b) and (c) As the present production of billets is not sufficient to meet even one shift capacity of Registered re-rollers, it has not been possible to meet the full requirements of the Re-rolling Mills, including those of Tamil *i* Nadu. Efforts are being made to step up production and despatches from steel plants. Government has no information!

about retrenchment in, or closing of, any unit in Tamil Nadu for want of billets.
