A-10 Up and T-22 Up local trains, who were clinging to the door handles and leaning outside these trains, were struck by a portion of the damaged gate of Parel Loco Workshon between Parel and Curry Road stations on 21-3-1970.

In this incident no one was killed. However, 52 persons sustained injuries of whom 33 were hurt grievously.

(b) Passengers of A-10 Up and T-22 Up were struck by the damaged gate at 8.39 and 8.51 hours respectively.

(a) whether the Government of Kerala have requested the Central Government to set up a steel plant at Calicut; and

(b) if so, what decision has been taken by Government thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRI MOHD. SHAFI QURESHI): (a) Yes, Sir.

(b) The Geological Survey of India is yet to complete its pre-investment study of the iron ore deposits at Kozhikode. It is only after this study is complete, Government would be able to take a view on any investment proposal based on the findings thereof.
