**APPLICABILITY OF THE  
INSURANCE AMENDMENT ACT,  
1968 TO GENERAL INSURANCE**

(a) whether it is a fact that the entire provisions of the Insurance Amendment Act, 1968 have been made applicable to General Insurance business; and

(b) if not, which are the Sections, which have not so far been made applicable and what are the reasons there for?

THE MINISTER OF SUPPLY AND THE  
MINISTER OF STATE IN THE MINISTRY  
OF FINANCE (SHRI R. K. KHADILKAR) :

(a) and (b) Provisions of the Insurance (Amendment) Act, 1968, other than those of sections 14 and 41 thereof, were brought into force with effect from 1-6-1969. As regards section, 14 and 41, an assurance was given by the Government during the consideration of the Insurance (Amendment) Bill, 1968, by the Joint Committee on the Bill that the sections would not be brought into force until Payment of Bonus Act, 1965, was suitably amended in relation to employees of insurance companies carrying on general insurance business. The question of suitable amendment of the Payment of Bonus Act, 1965, is under consideration of the Ministry of Labour, Employment and Rehabilitation.

(d) if so, what steps Government have taken in this direction?

(b) Yes. Eight private medical colleges charge capitation fees.

(c) As far as Government of India is aware Rs. 6,000 per student are charged by the Kasturba Medical College, Mangalore.

(d) The State Governments concerned have been advised to discourage the opening of private Medical Colleges which depend for their existence on high capitation fees, and/or high tuition fees.
