THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI D. R. CHAVAN) : (a) and (b) A memorandum purporting to have been issued by the Akhil Bharatiya Indian Oil Dealers Association has been received. This contains the following points:—

(i) that the IOC is supplying its products to M/s. Esso & IBP at a low price;

(ii) that the IOC is defying the recommendations of the Estimates Committee in this regard; and

(iii) that Shri S. B. Budhiraja, Ex-Manager in the IOC and now Managing Director, IBP, is misusing his powers; etc.

**CHECKING OF QUACKERY IN MEDICAL
PROFESSION**

Will the Minister of HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT be pleased to state:

(a) whether Government have taken any steps to check quackery in the medical profession in the country; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (DR. S. CHANDRASEKHAR) : (a) and (b) Sub-section (2) of section 15 of the Indian Medical Council Act, 1956, prohibits practice in modern medicine by medical practitioners not enrolled in a State Medical Register. Any person who acts in contravention of this provision is liable to be punished with imprisonment for a term which may extend to one year, or with fine which may extend to one thousand rupees, or with both. These provisions are considered sufficient to check quackery in the medical profession.
