†[UNDERUTILISATION OF LABOUR IN PHARMACEUTICAL FACTORY, MADRAS

902. SHRI RAM SAHAI: Will the Minister of HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT be pleased to state:

- (a) what is the average number of labour hours which are utilised and which remain unutilised in the Pharmaceutical Factory a Madras; and
- (b) whether the number of labour lours which are utilised is on the low side, if so, the reasons therefor and what steps are proposed to be taken for remedying this situation?]

स्वास्थ्य तथा परिवार नियोजन और निर्माण, आवास और नगर विकास मंत्रालय में राज्य मंत्री (श्री बी० एस० मूर्ति) : (क) क्रमश: 62 प्रतिशत और 8 प्रतिशत ।

- (ख) 70 प्रतिशत को सामान्य मानते हुए 62 प्रतिशत कम है। कारण इस प्रकार हैं :--
 - ं (i) कर्मचारी अनुभवी होते हुए भी अधिक उम्र के हैं ।
 - (ii) घिसा-पिटा सगंत्र और मशीनरी।
 - (iii) अनुषयुक्त इमारतें ।
 - (iv)कच्ची सामग्री के जिसके लिए फैक्टरी को अन्य ऐजेन्सियों पर निर्भर करना पड़ता था, प्राप्त होने में अनिश्चितता ।
 - (v) औषध नियमों के अधीन जिन नमूनों का परीक्षण अपेक्षित है उन्हें देखते हुए विश्लेझ षक कैमिस्टों की अपर्याप्तता ।
 - (vi) कुछ चीजों के निर्माण का बन्द होना।

जहां तक सुधार विशयक कदमों का प्रश्न है तुरन्त उपाय के रूप में चार अतिरिक्त विश्ले-पक कैमिस्टों की स्वीकृति दे दी गई है। मद्रास के चिकित्सा सामग्री भण्डार के कार्य संचालन को जिसमें उससे सम्बद्ध फैक्टरी भी सम्मिलित है, सुधारने की योजन ओं पर भी चिकित्सा

सामग्री भण्डारों के पुनर्गठन की योजना के साथ साथ विचार किया जा रहा है।

†[THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI B. S. MURTHY): (a) 62 percent and 8 percent respectively.

- (b) Considering 70 percent as normal, 62 percent is on the low side. The reasons are as follows:
 - (i) Employees, though experienced, are aged.
 - (ii) Worn out Plant and Machinery.
 - (iii) Unsuitable buildings.
 - (iv) Uncertainty regarding receipt of raw materials for which the Factory had to depend on other agencies.
 - (v) Inadequacy of Analytical Chemists relative to the samples requiring tests under the Drugs Rules.
 - (vi) Discontinuance of manufacture of certain items.

As far the remedial steps, as in immediate measure, four additional Analytical Chemists have been sanctioned. Plans to improve the working of the Medical Store Depot at Madras including the Factory attached to it are also under consideration alongwith the scheme of reorganisation of Medical Store Depots.]
