#### HINDI OFFICE of the MINISTRY OF FINANCE

\*483. SH. QMATI VIDYAWATI CHATURVEDI: Will the PRIME MINISTER be pleased to state:

(a) whether an enquiry by the Central Bureau of Investigation has been ordered to go into the charges against the Hindi Officer of the Ministry of Finance, who is alleged to be involved in a smuggling racket;

(b) if so, the time by when the investigations are likely to be completed;

(c) if the reply to part (a) above be in the negative;

(d) whether, in view of the gravity of the charges the officer concerned has since been suspended; and

(e) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI P. C. SETHI): (a) to (c) No, Sir. Since the allegation is about the officer's link with smugglers, the investigation has been entrusted to the Director General, Revenue Intelligence & Investigation. While every effort is being made to expedite the investigation, it is not possible to indicate the precise time by which it would be completed.

(d) and (e) No *prima facie* case warranting a suspension from service has emerged so far.

SHRI GANESHI LAL CHAUDHARY :

Will the PRIME MINISTER be pleased to state:

(a) the total number of staff cars in the various Ministries of the Government of India and in their attached offices and the number of indigenous and imported ones out of the same;

(b) the details of the journeys in terms of kilometers performed by the officers and staff of the Ministries by these cars during the year 1969-70 Ministry-wise;

(c) whether Government propose to run staff car service on the pattern of bus service throughout Delhi and New Delhi to enable the Government officials to perform journeys when on official duty by producing an authority letter; and

(d) if not, what steps are proposed to be taken to stop the misuse of the staff cars and to make them available to the staff also for official work?

(ग) जी नहीं ।

(घ) मंत्रालयों को पहले ही आदेश जारी कर दिये गये हैं कि उनके अधीनस्थ स्टाफ कारों का सर्वाधिक औचित्य पूर्ण तथा मितव्ययी प्रयोग किया जाय । इसके अलावा, स्टाफ कार नियमावली में यह व्यवस्था है कि स्टाफ कारों का प्रयोग मनोरंजन स्थलों, दावतों और बिहार स्थलों आदि की यात्राओं के लिये नहीं किया जाय । स्टाफ कारों के उचित प्रयोग, देखभाल और रख रखाव के लिये और उनकी यात्राओं को सामान्यतः इन नियमों के अनुसार विनियमित करने के लिये एक नियंत्रण अधिकारी को जिम्मेदार बनाया गया है (जो अवर सचिव से निम्नतर पद का नहीं होता) । स्टाफ कारों का दुरुपयोग नहीं होने देने का इत्मीनान करने के लिये प्रत्येक मंत्रालय में एक वरिष्ठ अधिकारी भी महीने में एक बार स्टाफ कार की लागवुक की छानबीन करता है ।

स्टाफ कार नियमावली में पहले से ही यह व्यवस्था है कि वास्तविक सरकारी प्रयोजनों के लिये, नियंत्रण अधिकारी की पूर्व अनुमति लेकर अराजपत्रित कर्मचारी भी स्टाफ कारों को काम में ले सकते हैं ।

TITHE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI P. C. SETHI): (a) and (b) The information is being collected from the Ministries/Departments concerned and will be laid on the Table of the House as soon as possible.

(c) No. Sir.

(d) Instructions have already been issued to the Ministries to ensure the most efficient and economic use of the staff cars under their control. Besides this, Staff Car Rules prohibit the use of staff cars for journeys to places of entertainments, parties and pleasure trips, etc. The Controlling Officer (an officer not below the rank of an Under Secretary) has been made responsible

for the proper use, care and maintenance of the staff cars and for regulating its journeys generally in accordance with these rules. A senior officer in each Ministry also scrutinises the log book once a month to ensure that there is no misuse of staff cars.

The Staff Car Rules already provide that staff cars may be used by members of the non-gazetted staff also for bona-fide official purposes with the prior approval of the Controlling Officer.]

#### SHIFTING OF FRUIT AND VEGETABLE MARKET FROM SUBZIMANDI, DELHI

(b) The market will be shifted to the new site at Azadpur after the allottees of the plots have constructed their shops.
