## STUDENTS IN PRIMARY SCHOOLS

- 976. SHRI TR1LOK.I SINGH: Will the Minister of EDUCATION AND YOUTH SERN ICES be pleased to state:
- (a) the reason, tor which more man seventy-five per cent students leave the schools before tney reach Class V even in areas where i ampulsory education is in force; and
- (b) what steps Government propose to take to ensure t at children once entering a primary chool do not leave it before passing c ass V?

THE MINISTER OE STATE IN THE MINISTRY" OF EDUCATION AND YOUTF SERVICES (SHRI BHAKT DARSIAN): (a) The main reasons are: (i) Economic backwardness resulting in the involvement of the pupils in domestk: work for assisting parents; and (ii) social prejudice against schooling of gii Is particularly in rural areas;

- (b) The follov ing measures arc being adopted by Stat; Governments:
  - 1. Midday neals scheme;
  - 2. Supply of free uniform to needy students partii ularly to girls;
  - 3. Supply ( f free books to needy children;
    - 4. Provisior of school mothers;
  - 5. Provisioi of creches in villages so that infants can be looked after releasing gro\n up boys and girls to attend school
  - 6. Arranging school instructional hours to suit local needs;
  - 7. Educatin { parents through parent teacher assoc ations:
  - 8. Making the curricula interesting to attract children to school;
  - 9. Providing vocational bias to the instruction so that the skills can of immediate use:
    - 10. Closer inspection of schools.

## ABOLITION OF P JSNIONS OF DESCENDANTS OF FORMER RULERS

- (a) the pensions payable to the descendants of the Moghal Emperors, King of Oudh, Tipu Sultan and other tuleis granted by the British Government and its predecessor in India prior to Independence are being paid now;

- (c) if the answer to part (b) above be in the negative, the reasons for discrimination between persons referred to in part (a) above and the former ruling princes referred to in Article 291 of the Constitution?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA):

- (a) Some of the political pensions granted by the British Government prior to Independence continue to be paid now.
- (b) and (c) The question of these pen sions has not been fully considered so far.

## DISCONTENT AMONG TRI3AL POPULATION

- 978. DR. DEBIPRASAD CHATTO-PADHYAYA: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government's attention has been drawn to the observation ol the Commissioner for Scheduled Castes and Scheduled Tribes made in the 18th Report to the effect that good intentions are becoming infructuous because of poor implementation, that frustration and discontent are mounting and spreading among the alienated tribal population and that law alone is of no assistance to them (1.36, 1.37, 1.38); and
- (b) if so, what steps Government propose to take to remove the ^rievancw of the tribal populations of West Bengal and Andhra Pradesh?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA):

(a) and (b) The Commissioner for Scheduled Castes and Scheduled Tribes in his Annual Report for the year 1968-69 has referred to the specific problem of restoration of land to the members of a tribal community called Tana Bhagats from their tribal co-villagers who are Christians in the State of Bihar. The suggestions made by the Commissioner in this regard have been forwarded to the Government of Bihar for their consideration.
