(b) The State Governments are taking action under the law to deal with the violent activities of the extremists. The Central Government keep in touch with the State Governments and provide such reasonable assistance as may be sought by them to deal with the activities of the extremists.

ADMISSION INTO ASHOKA HOTEL

(b) if so, the details thereof?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH) (a) Yes, Sir

(b) Admission is regulated as under

(i) Staff :

The staff can enter and leave the hotel only through the Staff Entry Gate, and are required to be in possession of identity cards

(ii) Guests

Guests who wish to stay in the hotel are expected to enter by the main entrance and proceed to Reception for the allocation of rooms. Likewise those who wish to use the restaurants use the respective entrances leading to the restaurants

(iii) Visitors :

Visitors having business in the hotel or an appointment with Management personnel are expected to come through the Main entrance. Visitors wishing to see the hotel are issued passes and conducted round the hotel

(iv) Admission to the Bar

(i) Foreigners can be served drinks on any day

(ii) Indian resident guests can be served drinks on non-dry days

(iii) Indian non-resident guests can be served drinks if they accompany a foreigner on a non-dry day when the foreigner is the host

(a) whether it is a fact that Buddhists took out an anti-police procession in New Delhi on the 27th April, 1970, and

(b) if so, what were their grievances against the Delhi Police?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) (a) and (b) A procession was taken out on 2 th April, 1970 by

the Buddhist to protest against the arrest and illtreatment of a Boudh Bhikshu Sanghapala alias Dinawala on 4th April, 1970 in connection with the alleged kidnapping of three children by him. It was alleged that the police acted rashly and mistreated and humiliated this Bhikshu after implicating him in a false case.
