THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRI MOHD. SHA-FI QURESHI): (a) and (b) No Sir. It is not proposed to take up construction of Steel Plant at Bailadilla during the Fourth Plan. Bailadilla along with other suitable sites in the country will be considered for future Steel Plants that may be set up during subsequent plan periods.

PRACTICE OF FORCED LABOUR IN INDIA

- 13. CHAUDHARY A. монам-MAD: Will the Minister of LAW AND SOCIAL WELFARE be pleased to state:
- (a) the names of places in the country where the practice of forced labour is in vogue; and
- (b) the steps so far taken to abolish the said practice, the results achieved therefrom and the details of further programme in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF LAW AND IN THE DEPARTMENT OF SOCIAL WELFARE (DR. SHRIMATI PHUL-RENU GUHA): (a) Under article 23 of the Constitution, traffic in human being and begar and other forms of forced labour are prohibited and any contravention of this provision is an offence punishable in accordance with law. However, the system of bonded labour is prevalent in some States, e.g., Orissa, Rajasthan Andhra Pradesh.

(b) The State Governments are fully seized of the problem and, have taken various executive and legislative measures to combat this evil. A statement showing these various measures is placed on the Table of the House. [See. Appendix LXXII, Annexure No. Various welfare programmes for the social, educational and economic uplift of the affected people are in progress and these are being further expanded under the Fourth Plan.

GRANT OF SCHOLARSHIPS TO STUDENTS BELONGING TO SCHEDULED CASTES AND SCHEDULED TRIBES

14. CHAUDHARY A. MOHAM-MAD: Will the Minister of LAW AND SOCIAL WELFARE be pleased to state:

- (a) whether in view of increase in the number of students belonging to the Backward Classes, Scheduled Castes and Scheduled Tribes, Government propose to increase the amount of scholarships to such students; and
- (b) if so, to what extent and in what manner?

THE MINISTER OF STATE IN THE MINISTRY OF LAW AND IN THE DEPARTMENT OF SOCIAL WELFARE (DR. SHRIMATI PHUL-RENU GUHA): (a) and (b) scholarships to the Other Backward Classes are awarded from 1969-70 by the State Governments from their resources and they are free to lay down their own standards including the rates of scholarships.

As regards the Scheduled Castes and Scheduled Tribes the terms of award including rates of post-matric scholarships are laid down by the Centre. The Central Government also meets the increase in expenditure over the 1968-69 level committed to the States' budgets. The question of increasing the rates of scholarships was considered but could not be agreed to due to financial constraints.
