- (a) whether it is a fact that after the termination of the Managing Agency system, the Directors of the Tata Iron and Steel Company and the Indian Iron and Steel Company have given extra remuneration in some shape or form to their old Managing Agents or their nominees which was not being given before the termination of the Managing Agency system; and

b) if so, how much amount and in what form has been given to each of them and how do these amounts compare with the payments made to the Managing Agents in the past?

MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) The Tata Iron &. Steel Company has submitted applications for the appointment of one Managing Director and two Whole-time Directors and the payment of commission to the other Directors of the company at 1% of the net profits, and these proposals have been approved by the shareholders of the company. The applications of the company are under consideration. Tata Iron & Steel Company has not made any other arrangement with the former Managing Agents. The Indian Iron & Steel Company by Resolution of the Board of Directors dated the 17th March, 1970 appointed M/s. Martin Burn Ltd. its erstwhile Managing Agents as "Secretaries" to the company on monthly remuneration of Rs. 12,500 for a period of 5 years for performing various duties. By another resolution of the Board of Directors, a committee of Directors consisting of three Directors is to be formed with a view to carry on the day-to-day operations of the company's affairs and each of the members of the committee will be paid by way of remuneration for his services a sum of Rs. 100 for each meeting of the committee attended by him

(b) The Managing Agents of Tata iron & Steel Company were receiving commission of Rs. 45 lakhs per annum as their remuneration as Managing Agents of the company. The amount proposed to be paid to the Managing Director/Whole-time Directors and other Directors of the company will be about Rs. 9 lakhs per annum. The Managing Agents of Indian Iron & Steel Company were paid Rs. 31,07,609 as their commission for the year endini> March, 1969, Rs. 9,74,776 for the year 1968 and Rs.. 30,66,420 for the year 1967. The amount, which is now proposed to be paid to the "Secretaries" and the other Directors of the company, would be less than the amount which the company was paying to its Ex-Managing Agents.
