## MSP for Rabi Crops

- (c) whether Government propose to increase or revise the remunerative prices of Rabi crops in view of the high costs of inputs of farm products after increase in petro prices; and
  - (d) if so, by when, and if not, the reasons therefore?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI KANTI LAL BHURIA) (a) and (b) The Minimum Support Price (MSP) of wheat at Rs. 640 per quintal covers the A2+FL cost (actual expenses in cash and kind incurred in production+rent paid for leased-in land+imputed value of family labour) in all the major wheat producing State while it falls short of C2 cost (actual expenses incurred in cash and kind, rent for leased-in land imputed value of wages of family labour, rent for owned land and interest on fixed capital) only in Himachal pradesh and Madhya Pradesh. The MSP of rapeseed/mustard at Rs. 1700 per quintal adequately
