ARORA : Sir, on SHRI ARJUI a point of order. The Consumer Cost of Living Index i issued every week. The Minister is misle dang the House when he says that it is ssued for a month and thereafter, for the succeeding month, it is issued after he expiry of six weeks from the end of the preceding month. They are issued every reck, Sir, and the Press Information Bure u circulates them. So the Minister has ruisled the House in trying to evade an answer to the crux of the question.

SHRI P. C. ETHI: Sir, according to the information which I have, in terms of the Desai Ban Award of June, 1962, the All-India Working Class Consumer Price Index has a Depublished regularly in the Gazette of I dia after a delay of not more than a x weeks from the end of the relevant 1 onth.

SHRI ARJUN ARORA: It is issued every week. I go i every week. He has either been misi formed, or he is misleading the House.

SHRI P. C. SETHI: I am not the least trying to m slead the House. I am stating the position as per my information (Interruptions). I would certainly check up, and if there say wrong information that I have been supplied with, I would certainly correct t.

SHRI KRISH AN KANT: Mr. Chairman, because (overnment do not have any information is to what is the impact of the latest. I idget on the consumer price index, may I know this, Sir? Have they any pricing policy? Because of the Budget have they any price policy or any policy to st bilise prices because in the Fourth Plan and in the earlier three Plans nothing is given regarding the pricing policy. May I know, Sir, what attempts Government have made, what

is the policy regarding stabilising of prices and what the Government propose to do? If they are going to give some information after the Price Index Report is received, with the permission of the hon. Chairman we may have a discussion on the subject of the increase in the consumer price index when the Government receive a report about this, as stipulated by them, after six weeks, in the second week of May, when we will come to know the impact of the Budget on the consumer price index.

SHRI P. C. SETHI: As far as the pricing is concerned, certainly the prices of important commodities are taken into account, and the Government and the Reserve Bank and all banking institutions constantly endeavour to see that the price index does not rise. But, Sir, some price increase. . .

SHRI KRISHAN KANT: What is the endeavour made?

SHRI P. C. SETHI: Now about the impact of the Budget on prices. As far as the position about the price increase after the presentation of the Budget is concerned, there has been about one per cent, increase.

MINING OF CAPTIVE JAT RAJ SEAM OF KORBA

- (a) whether it is a fact that the Madhya Pradesh Government had agreed to the mining operations of this Captive Jat Raj Seam of Korba by the National Coal Development Corporation on the assurance of the Government of India representatives to the effect that the cost of middlings would be about Rs. 10/- per ton and the raw coal would be even cheaper;
- (b) if so, the price now charged and the reasons therefor;

- (c) whether the high price results in uneconomic power generation at Korba;
- (d) if so, whether Government propose to consider reduction in the price of the above commodities;

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI JAGANNATH RAO): (a) No, Sir.

(b) to (f) From 16th November, 1959 the Madhya Pradesh State Electricity Board have been paying a price of Rs. 16.73 per tonne only for Jatraj coal supplied by the National Coal Development Corporation. This is much less than the price billed by the Corporation. The dispute regarding the price is currently under arbitration.

Use of D. D. T.

*36. DR. DEPIPRASAD CHATTO-PADHYAYA: Will the Minister of HEALTH AND FAMILY PLANNING AND WORKS, HOUS'NG AND URBAN DEVELOPMENT be pleased to state:

- (a) whehter Government's attention has been drawn to the reported expert opinion that use of D. D. T. poses health hazard; and
- (b) if so, what steps Government have taken or propose to take in this matter?

THE MINISTER OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI K. K. SHAH):
(a) The Government is aware of the reported apprehension about the likely injurious effects of D. D. T. on human life.

(b) An Expert Committee comprising the representatives of Ministries of Agriculture and Food, Petroleum and Chemicals, Health, Indian Council of Medical Research, W. H. O., U. S. A. I. D. and Pesticides Association of India is looking into the effects of the continued use of D. D. T. and other pesticides. This committee has set out guidelines for further research on the possible hazards of D. D. T. to human health.
