

THE DEPUTY MINISTER IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS AND IN THE MINISTRY OF SHIPPING AND TRANSPORT (SARDAR IQBAL SINGH): (a) No, Sir. It is proposed to send an official team shortly for discussions with M/s Mitsubishi Heavy Industries Ltd., Tokyo, Japan in regard to their technical collaboration in the construction of the Cochin Shipyard and to conclude an Agreement with them for the purpose.

(b) Preparatory works like acquisition of land, land and soil surveys, provision of water and electricity, diversion of road traffic, had already been taken in hand and are in progress. A project organisation will also be set up shortly and the actual construction is expected to commence during the current year. The work will be progressed on the basis of the allocation of funds from year to year.

(c) Out of the total cost of Rs. 45.42 crores, the foreign exchange component is estimated at Rs. 5.63 crores.]
