

(b) As a result of the situation created by the imposition in 1965 of embargoes by a number of western countries on the export of arms and ammunition and other vital defence stores to India, a special arrangement was made with two parties for the procurement of spares for a transport aircraft. The arrangement for the procurement of spares with these two parties lapsed on 31-1-1970. A review of the need for the continuance of such an arrangement has been made recently and it is proposed not to renew the agreement with these two parties.

VILLAGES ELECTRIFIED DURING THE GANDHI CENTENARY

(a) the number of villages which were electrified during the Gandhi Centenary Year; and

(b) the period by when Government expect to cover the whole of the country?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (PROF. SIDDHESHWAR PRASAD) : (a) Against a target of one lakh villages to be electrified by the end of Gandhiji's Centenary Year i.e. by 2nd October, 1970, 65422 villages have been electrified by 31st March, 1970 out of which 11868 villages were electrified from 2nd October, 1969, to 31st March, 1970.

(b) The time by which the remaining villages would be electrified would depend on the funds available for rural electrification in the subsequent Plan periods.

(d) if so, what is the reaction of the Government of India in the matter?]

LIFTING OF EXPORT DUTY ON JUTE AND TOBACCO

(a) whether it is a fact that there is a demand for lifting of export duty on jute and tobacco;

(b) if so, the reaction of Government in the matter; and

(c) whether it is also a fact that there is an apprehension of losing overseas markets in the presence of export duty on these items?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (CHOWDHARY RAM SEWAK) : (a) to (c) Representations have been received from time to time for abolition of export duties on jute goods and tobacco. Export duties on certain types of jute manufactures have been abolished whereas in the other cases the duties have been considerably reduced. Government do not consider that the total abolition of export duties on jute manufactures at the present juncture will help in pushing up exports in view of current shortage of their production and high prices.

As regards tobacco, Government is not in favour of abolition of export duty as exports have not been affected due to the incidence of duty.

INCREASE IN COTTON PRICES

(a) whether it is a fact that the prices of cotton are increasing;

(b) if so, what corrective measures Government propose to take in the matter; and

(b) Besides adjustments in credit and stock control, additional imports of cotton/staple fibre have been and are being arranged.
