MR. DEPUTY CHAIRMAN: Order, order.

SHRI ABID ALI: I am one with the hon. Member in condemning this. I don't say it but it is AH India Radio. It is Indiraism that is existing in this country and Government offices have come to that extent that a Government official himself had to say it. So. Sir, as soon as I heard this, I wrote to the hon. Minister. Shri Satya Narayan Sinha, and then sent three reminders, and I am mentioning here today that even after three reminders he did not reply. And then I requested the Chairman that this matter should be mentioned here by me so that Government may have an opportunii; to tell the people that this is not the system of Government offices. Although I am in the opposition I want a good system to prevail and I want that Government offices should not be maligned to that extent although there are bad officers and dishonesty. So what has ihe hon. Minister to say about this question?

THE MINISTER OF STATE IN THE OF MINISTRY INFORMATION AND BROADCASTING AND IN THE DEPERTMENT OF COMMUNICATIONS (SHRI I. K. GUJRAL): Sir, becciuse I did not have prior notice for this I am not prepared to reply in detail, but I am aware that the hon. Member wrote to the hon. Minister on the subject, and I think a reply has either been sent to him or is being sent to him. The only thing that I can say at this stage is that the hon. Member has quoted something out of context totally. I am told that in the feature that was going on there was a long poem and as a pari of that this aho was mentioned as a satire on somebody. It was not as if it was being said as a feature by itself, and therefore it will be worth my hon. friend's while if he really quotes the whole thing and does not tear out one or two parts out of context.

SHRI ABID ALI: No, no. I am personally aware of the fact. He has information what has been given to him, which is absolutely wrong. Sir, the fact is that there was a talk, about the working of Govern-

[Shri Abid Ali] ment offices, on the television. The Government official while inaugurating the t"»lk said it, and generally these are the exact words. This is not out of context. This is the first sentence that was mentioned while introducing the talk, and the officer said this:

"जनाव, आज अपना विषय है गवर्नमेंट दफ्तरों में, उनकी कार्य पद्धति, इस बारे में हम चर्चा करेंगे। मामूली तरीके से लोग आज मान रहे हैं कि"

I am as much definite about it as I am talking here.

MR. DEPUTY CHAIRMAN: It was a sort of satire as the non. Minister pointed out

SHRI ABID ALI: No, no, it is absolutely wrong. The hon. Minister should kindly hear. Sir, while introducing the talk the first sentence was thi?:

SHRI ABID ALI: It is being sent. And that is a reply. So please, my request is that he should tell the television officers firstly that there have been so many irregularities, and I have sent a large number of letters to the Ministry about this.

MR. DEPUTY CHAIRMAN: That will do. You have had your say.

SHRI ABID ALI: I am finishing. On the television kindly at least mention that this was wrong and it was stupid for the officer to have made such a mention,

MR. DEPUTY CHAIRMAN: Well, of course I do not know what is the exact position about the programme and I do not have any comments to offer. B'Jt if hon.

Members are writing to hon. Ministers, it is desirable that the hon. Ministers should reply to the letters of the hon. Members in time. If the contention of Mr. Abid Ali is that he has sent three letters and he has not received a reply then this is not a satisfactory position and I hope, in future at least hon. Ministers will extend this much courtesy to the hon. Members by replying in time.

SHRI K. S. CHAVDA (Gujarat): Sir, I would like to draw your attention to the list of Members of the Joint Committee. There are 15 Members and out of fifteen only eight are from the Opposition and seven are from the ruling Congress. My submission is that instead of seven, only five should be from the ruling Congress.

SHRI K. S. CHAVDA: Yes, according to the strength of the different political parties in the House. So two more seats should be given to the Opposition and out of the two one should be to my party.
