THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHR1 K. S. RAMASWAMY): Sir, I beg to lay on the Table, under clause (3) of article 356 of the Constitution, a copy of the Proclamation (G.S.R. No. 236) issued by the President on February 16, 1970, revoking the Proclamation issued on July 4, 1969, under the said article, in relation lo the State of Bihar (in English and Hindi). SHR1 SUNDER SINGH BHANDARI (Rajasthan): Sir, before you proceed I object lo the laying of these papers before the matter is clarified.

SHRI BHUPESH GUPTA (West Bengal): No, no. In that *cn.se* I oppose it. It should be opposed because the Swatantra Party has supported it...

SHRI LOKANATH MISRA: I am happy he opposes it...

MR. CHAIRMAN: Now, please sit down.

SHRI BHUPESH GUPTA: I want to make the position clear. We are not opposed to a discussion. If my friends want an early discussion, we are not opposed to it. Such a discussion h;\s to take place. We can express our viewpoints. I have a contrary point of view. My friend here does not know where he stands. He is chasing everybody.

MR. CHAIRMAN: 1 will consider whether a discussion should be allowed.
